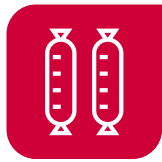

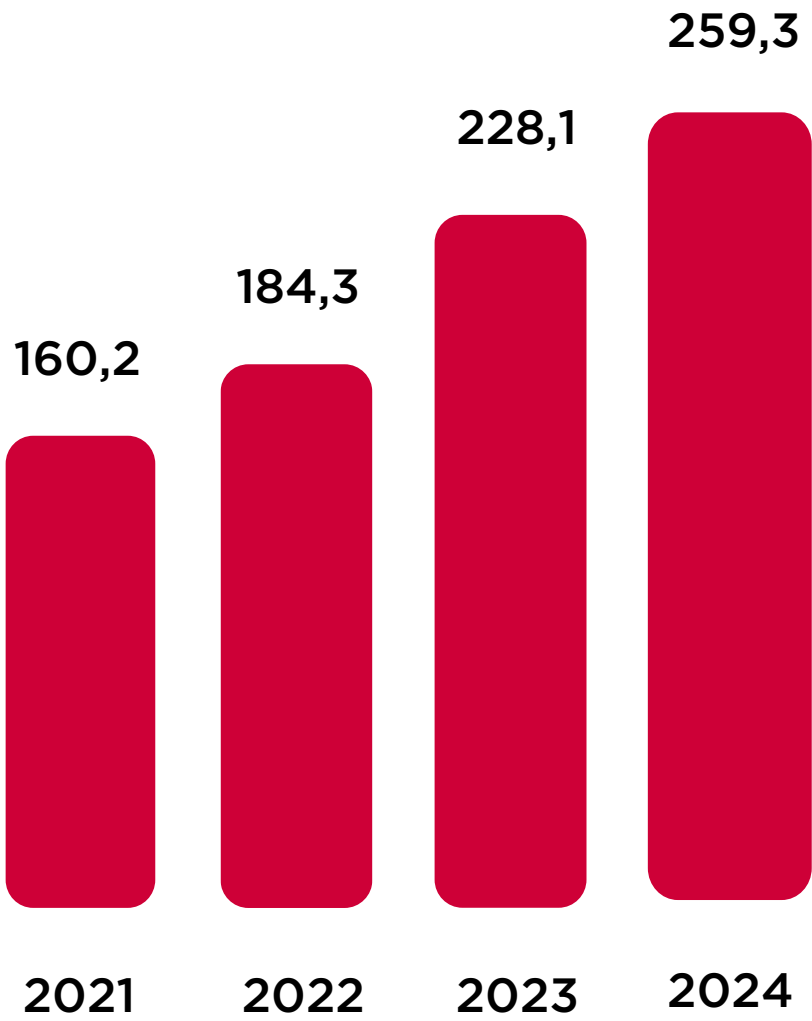

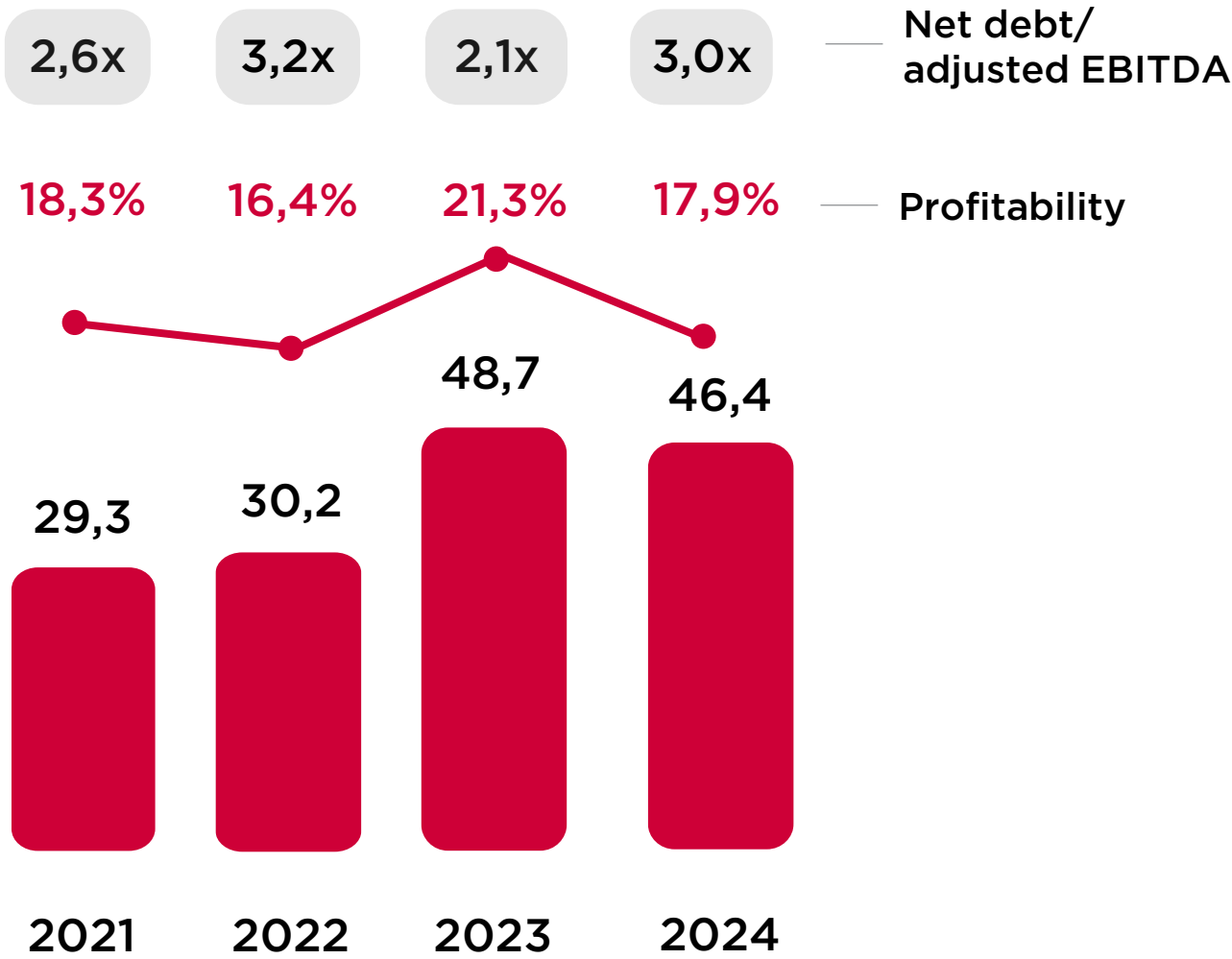

Key financial indicators

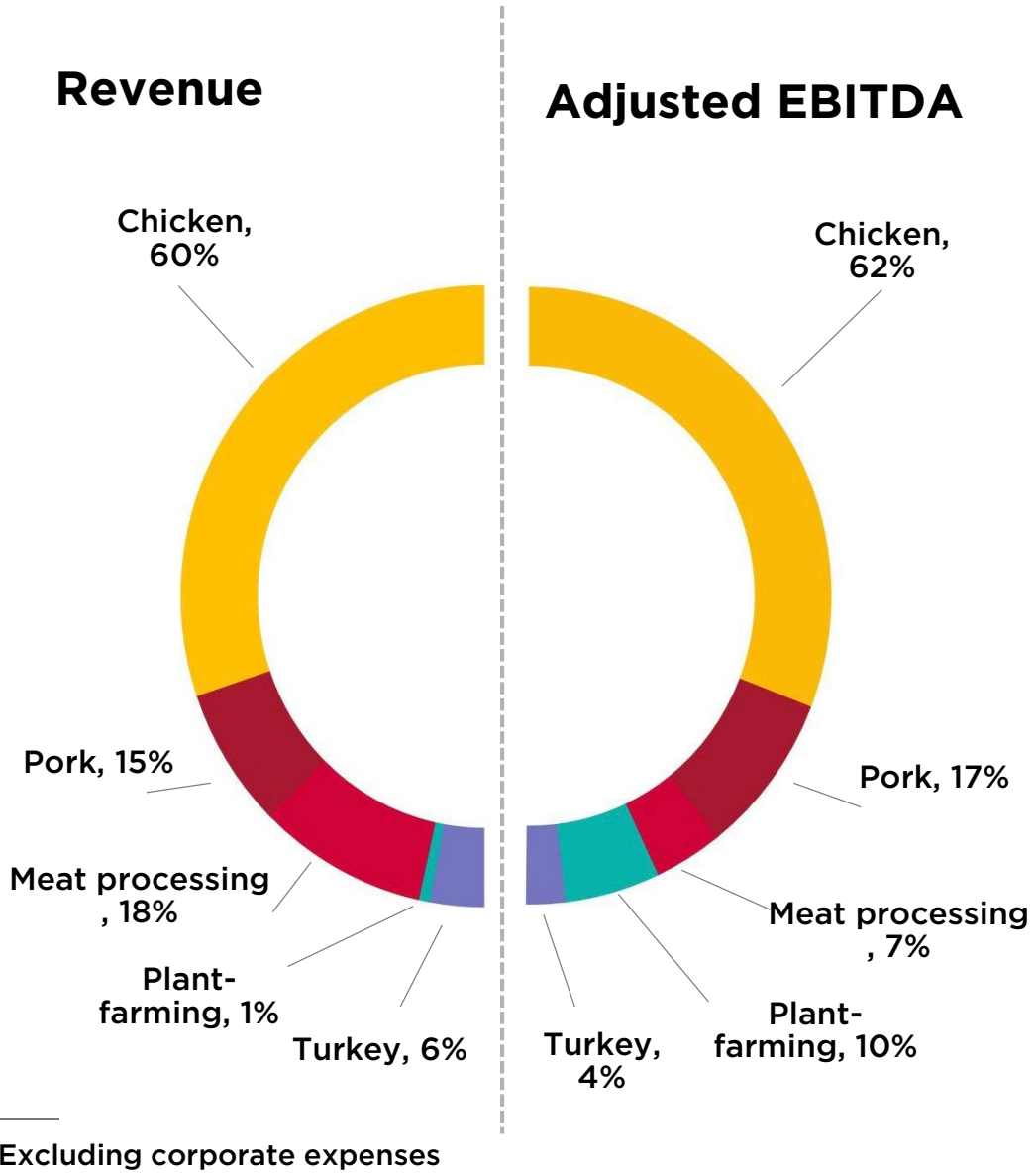
Revenue (billion rubles)
